The console has been manufactured in accordance with ISO9002.</p> <p>All electrical equipment is inspected and PAT every 6 months.</p>	<p>TOLERABLE</p>	<p>IMPROBABLE</p>	<p>MEDIUM</p>	<p>All equipment has a visual inspection on set up and pack down, any defects are reported to the operator and equipment is taken out of action until required remedial works have been carried out.</p> <p>The user limitations provided by manufacturer to be followed at all times.</p> <p>Our team have procedures in place should deflation occur.</p>

Inflatable must be not be used until it is dry.</p>

Generator and risk of fire	Injury to Operator, Spectators or Participants	Injuries caused by: Fire Heat	<p>Generators are filled with fuel before delivery and must remain a minimum of 5m away from equipment in an off fenced area.</p> <p>Under no circumstances should anyone other than our team enter the fenced off area where the generator is.</p> <p>No smoking or BBQs should be within 5m of the equipment.</p>	UNDESIRABLE	IMPROBABLE	MEDIUM	<p>All hires where generators will be used will be set up with an earth rod and a fire extinguisher provided.</p> <p>All spare fuel is stored in suitable marked containers and in a safe location.</p> <p>All items must be switched off during refueling.</p> <p>Equipment is fire retardant.</p>

Any other action required:

This risk assessment is specific to the equipment and covers the set-up, use and pack down.
